## Terms and Conditions

1. There is no fee for a customer to enroll in the Hart & Iliff Budget Plan and Automatic Fill Program. The enrollment deadline is September 30, 2025.
2. The budget year for billing is 11 months, May through March, with any outstanding balances also being due in April.
3. All customers in the Budget Plan must also be enrolled in the Automatic Fill Program and must start the program with a full tank if oil that must be paid in full.
4. Hart & Iliff will monitor customer's usage and will schedule delivery amounts and dates at its sole discretion. If Customer anticipates an increase or decrease in consumption based on reasons unknown to Hart & Iliff (example: home remodeling project), Customer will notify the Hart & Iliff office.
5. Your budget dollars are to be used for deliveries only. Any other costs incurred must be paid separately.
6. Hart & Iliff may adjust by raising or lowering Customer's monthly payments under this plan and will notify the customer in writing via mail.
7. Hart & Iliff may conduct an initial credit check and reserves the right to determine the Customer's continued eligibility in Plan throughout the year.
8. Hart & Iliff will send Customer monthly invoices. Payments will be made by the 15<sup>th</sup> of every month. If Customer is late 10 days, then the Customer will be notified in writing of removal from Plan.
9. Hart & Iliff reserves the right to suspend deliveries for non-payment, acts beyond control, or if deliveries would endanger personnel, property, or the environment.
10. Hart & Iliff's heating oil prices do fluctuate and are subject to market conditions and product availability.
11. Customer will automatically be re-enrolled in the Budget Plan if no written cancellation is provided. Customer may opt out at any time with a 30-day written notice. **The Budget Program is not refundable.**
12. Customer is responsible for providing safe access to the delivery site in all weather conditions and acknowledges that the fuel storage tank is in sound condition and suitable for safe delivery and storage heating oil. Customers should notify Hart & Iliff 10 days prior to any changes to the receiving tank or associated piping.
13. In no event will Hart & Iliff be liable for any special, incidental, consequential, punitive, or indirect damage, whether based on contract, tort (including negligence), indemnity, warranty, strict liability, or otherwise resulting from this agreement shall not exceed one thousand (\$1000) dollars.
14. Customer authorizes Hart & Iliff to charge or electronically debit the Customer's credit card or checking account on file.
15. Customer agrees to pay/ reimburse Hart & Iliff for any fees associated with the collection of past due receivables.
16. This offer cannot be combined with any other offer.
